Comment year 2017

The year 2017 was the fourth year our foundation executed our most important activities such as twin scholarship (three students from Indonesia and one student from the Netherlands). and the yearly seminar for young potential leaders from several sectors of the society like business, academia, government, ngo's; ten from Indonesia and ten from the Netherlands.

In 2017 the foundation was also active in attracting new members for the board, which will be appointed in 2018!

The donations in 2017 were equal with the previous year.

With respect to our plans for 2017 (see our report of last year) we are quite happy to mention now that the Frans Seda Foundation received a very interesting contribution from Kompas company in Indonesia, mainly for the lodging expenditures of the twenty participants of the seminar. We aim to realize in the near future a more equal contribution from Indonesia and The Netherlands.

As stated in the ANBI requirements the compensation for the board members has been limited to a compensation of expenditures.

Our internal rule is that the compensation of flight costs is one flight in a year.

The board usually communicated by internet, phone and skype conference.

We meet at least once in a year.

The general expenses are still relatively because of the necessity of external professional support.

The total expenditures are comparable with last year.

Although the expenditures were 20.000 higher than our income we still maintained a relative strong cash position.
